Through these conservation activities, the native Moi Tribe was also engaged to participate in important events held at the park. The tribe performed traditional ceremonial rituals and provided their traditional

cuisine during these events, which were attended by government dignitaries.

Mr. Francis Chang, Group CEO and Executive Director, commented, "Southwest Papua is an area rich in plant and animal life. We are conscious of this and aim to minimise our environmental impact where possible. These conservation efforts are our contribution to ensuring that ecosystems and biodiversity

continue to thrive in the areas where we operate."

Besides PBL's conservation efforts within Sorong Nature Park, other conservation initiatives include the setting up of the Arar Conservation Center, which houses its own orchid conservation area as well as a nursery for plant seedlings native to the region. as vulnerable and near-threatened species.
