- 2. Bank of Ghana invites sealed Tenders through National Competitive Tendering for the Supply and Installation of nine (9no.) 30kVA Generator Sets. Tendering will be in accordance with the **National Competitive Tendering Method (NCT)** procedures as specified in the Public Procurement Act, 2003 (Act 663) as Amended and the Guidelines of the Public Procurement Authority (PPA) of the Republic of Ghana.

 - v. Valid Public Procurement Authority (PPA) Registration Certificate;



vi. Tender Security; and vii. Original Equipment Manufacturer's (OEM) Authorization letter
