[MOEF] Commencement of Preparations for Issuing the First-Ever Australian Dollar-Denominated Foreign Exchange Bond (November 8)

On November 7, the government finalized the selection of agencies for the issuance of Australian dollar-denominated foreign exchange stabilization bonds, officially commencing preparations for this issuance. This marks the government's first issuance of bonds denominated in Australian dollars. <u>More</u>

[MOEF] Consumer Price Index Climbed By 1.3% in October (November 5)

The consumer price index (CPI) in October 2024 rose by 1.3% y-o-y, down 0.3%p from September (1.6%), reaching the lowest rate of increase in 3 years and 9 months (45 months) since January 2021 (0.9%). More

[MOEF] Consumer Price Index, October 2024 (November 5)

The Consumer Price Index was 114.69(2020=100) in October 2024. The index remained unchanged from the preceding month and rose 1.3 percent from the same month of the previous year. More

During September 2024, the Korean current account registered a surplus of 11.12 billion dollars. Looking at the financial account, net assets increased by 12.68 billion dollars during September. <u>More</u>

Korea's official foreign reserves as of the end of October 2024 amounted to 415.7 billion dollars. More
