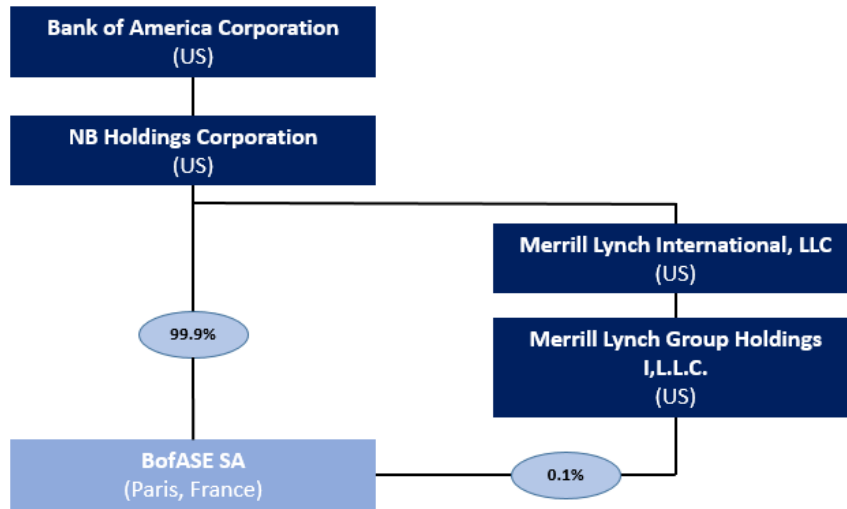

## Bank of America Ownership Structure for BofA Securities Europe SA



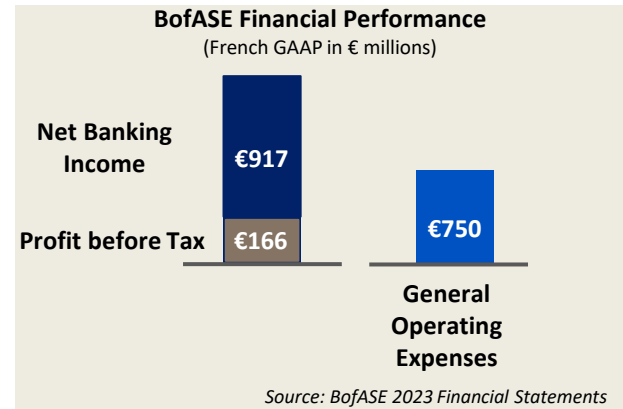

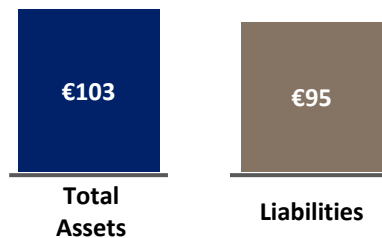

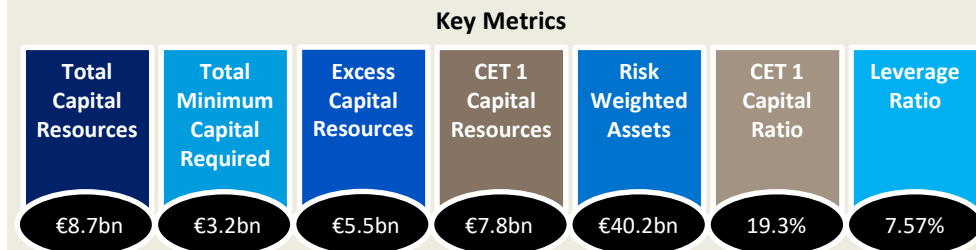
## Financial Position – as of 31 December 2023
