The notes provide exposure to the S&P® Global 100 PR 5% Daily Risk Control 0.5% Deduction Index (USD) ER (the "Index"). The Index attempts to provide variable notional exposure to the S&P® Global 100 Index (the "Underlying Index"), while targeting an annualized volatility of 5%, subject to the deduction, on a daily basis, of the notional financing cost and a daily deduction of 0.50% per annum. The Underlying Index is designed to measure the performance of 100 large-capitalization multinational companies whose businesses are global in nature and that derive a substantial portion of their operating income from multiple countries.
