5yrNC6m Auto Callable Contingent Interest Notes Linked to the MerQube US Tech+ Vol Advantage Index

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

Index Overview

The MerQube US Tech+ Vol Advantage Index (the "Index") attempts to provide a dynamic rules-based exposure to the underlying asset to which the Index is linked (the "Underlying Asset"), while targeting a level of implied volatility, with a maximum exposure to the Underlying Asset of 500% and a minimum exposure to the Underlying Asset of 0%. Since February 9, 2024 (the "Amendment Effective Date"), the Underlying Asset has been an unfunded position in the Invesco QQQ TrustSM, Series 1 (the "QQQ Fund"), calculated as the excess of the total return of the QQQ Fund over a notional financing cost. Prior to the Amendment Effective Date, the Underlying Asset was an unfunded rolling position in E-Mini Nasdaq-100 futures. The Index is subject to a 6.0% per annum daily deduction, and the performance of the Underlying Asset is subject to a notional financing cost deducted daily. The investment objective of the QQQ Fund is to seek to track the investment results, before fees and expenses, of the Nasdaq-100 Index[®].

Automatic Call

If the closing level of the Index on any Autocall Review Date is greater than or equal to the Initial Value, the notes will be automatically called for a cash payment, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to that Autocall Review Date, payable on the applicable Call Settlement Date. No further payments will be made on the notes.

If an automatic call is triggered on an Autocall Review Date that is not an Interest Review Date, the Contingent Interest Payment payable on the applicable Call Settlement Date will reflect proration based on the Day Count Fraction.

Payment at Maturity

If the notes have not been automatically called and the Final Value is greater than or equal to the Trigger Value, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment, if any, applicable to the final Review Date.

If the notes have not been automatically called and the Final Value is less than the Trigger Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return})$$

If the notes have not been automatically called and the Final Value is less than the Trigger Value, you will lose more than 40.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

Capitalized terms used but not defined herein shall have the meanings set forth in the preliminary pricing supplement.

Contingent Interest

* If the notes have not been previously automatically called and (a) on any Interest Review Date (including any Autocall Review Date that is an Interest Review Date), the closing level of the Index is greater than or equal to the Interest Barrier, you will receive on the applicable Interest Payment Date for each \$1,000 principal amount note a Contingent Interest Payment equal to at least \$12.9167 (equivalent to a Contingent Interest Rate of at least 15.50% per annum, payable at a rate of at least 1.29167% per month) or (b) on any Autocall Review Date that is not an Interest Review Date, the closing level of the Index is greater than or equal to the Initial Value, you will receive on the applicable Call Settlement Date for each \$1,000 principal amount note a Contingent Interest Payment calculated as follows:

$$\$1,000 \times \text{Contingent Interest Rate} \times 1/12 \times \text{Day Count Fraction}$$
