

5yr SPX Uncapped Dual Directional Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC
Guarantor: JPMorgan Chase & Co.
Minimum Denomination: \$1,000
Underlying: S&P 500® Index
Pricing Date: November 22, 2024
Observation Date: November 23, 2029
Maturity Date: November 28, 2029
Upside Leverage Factor: At least 1.00*
Barrier Amount: 70.00% of the Initial Value
Payment At Maturity: If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return} \times \text{Upside Leverage Factor})$$

If the Upside Leverage Factor is set at 1.00, you will not benefit from any upside leverage at maturity.

If the Final Value is equal to or less than the Initial Value but greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return})$$

This payout formula results in an effective cap of 30.00% on your return at maturity if the Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,300.00 per \$1,000 principal amount note.

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return})$$

If the Final Value is less than the Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

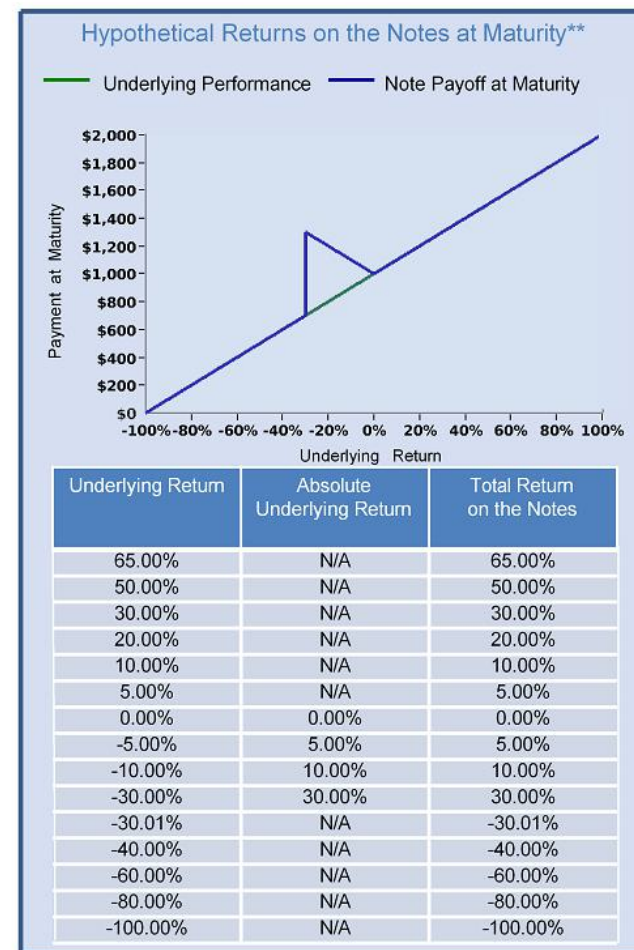
