Payment at Maturity:

If the Final Value of each Underlying is greater than its Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 *plus* the Additional Amount.

If the Final Value of either Underlying is equal to or less than its Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

In no event however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

If the Final Value of either Underlying is less than its Initial Value, you will lose up to 5.00% of your principal amount at maturity.

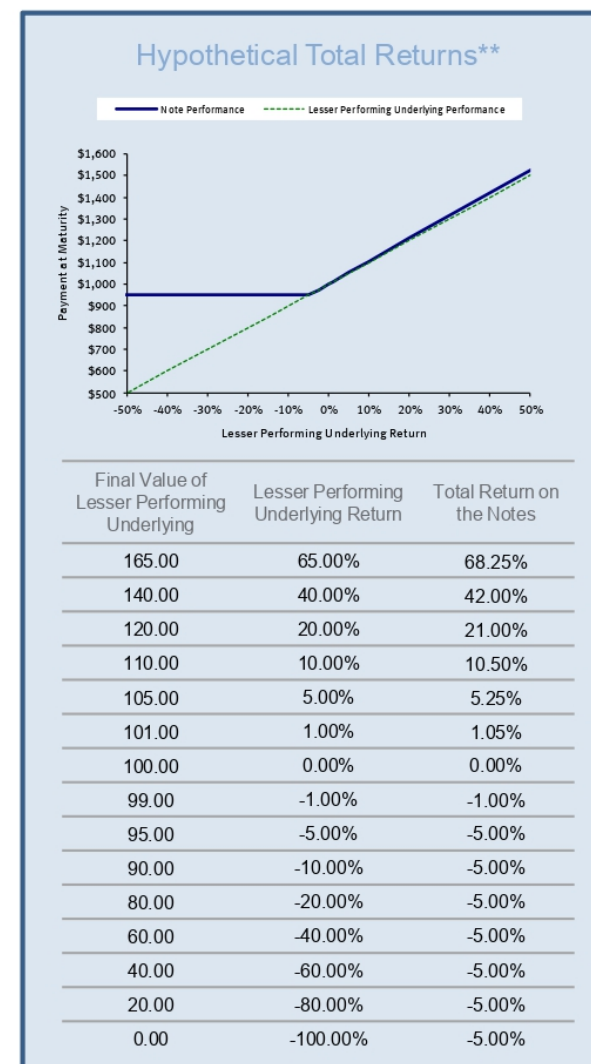
