# 4yr J.P. Morgan Dynamic Blend<sup>SM</sup> Index Notes

**J.P. Morgan**

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

### Overview

The notes provide exposure to the J.P. Morgan Dynamic Blend<sup>SM</sup> Index (the "Index"). The Index attempts to provide a dynamic rules-based allocation to the J.P. Morgan US Large Cap Equities Futures Index (the "Equity Constituent") and the J.P. Morgan 2Y US Treasury Futures Index (the "Bond Constituent") and, together with the Equity Constituent, the "Portfolio Constituents") while targeting a level volatility of 3.0%. The Index tracks the return of (a) a notional dynamic portfolio consisting of the Equity Constituent and the Bond Constituent, less (b) the daily deduction of 0.95% per annum. Each futures contract underlying a Portfolio Constituent as of a particular time is referred to as an "Underlying Futures Contract." The Equity Constituent is an excess return index that tracks the return of a notional rolling futures position in futures contracts on the S&P 500<sup>®</sup> Index. The Bond Constituent is an excess return index that tracks the return of a notional rolling futures position in futures contracts on 2-Year U.S. treasury notes.

### Return Profile

The notes pay interest annually for the first three years of the term of the notes. If the Final Value is greater than the Initial Value, at maturity, you will receive a cash payment that provides you with a return per \$1,000 principal amount note equal to the Index Return multiplied by the Participation Rate. **You will receive no interest payment on the Maturity Date.** If held to maturity, you will receive a full repayment of principal on your notes, even if the Index declines, subject to the credit risks of JPMorgan Chase Financial Company LLC and JPMorgan Chase & Co.

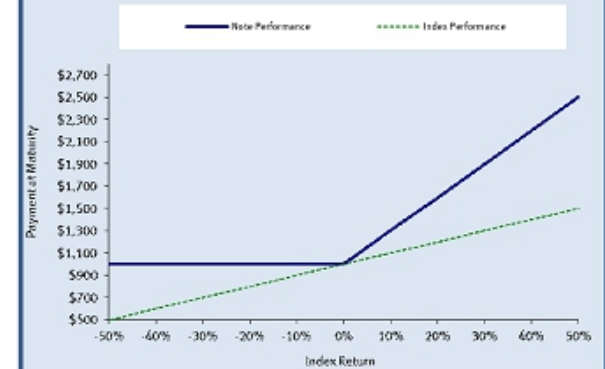

#### Selected Risks
