79,492,366 A-Shares were repurchased during 2021 but not yet cancelled, of which 25,440,807 A-Shares had been transferred to The 2021 A-Share Core Employee Stock Ownership Plan during July 2021. The balance of above A-Shares repurchased but not yet cancelled as at end of month is 54,051,559 shares (treasury shares), and will be cancelled in accordance with a resolution of 2023 annual general meeting.

During April 2022 to January 2023, a total of 59,768,139 A-Shares were repurchased but not yet cancelled, 26,814,055 A-Shares had been transferred to The 2022 A-Share Core Employee Stock Ownership Plan during July 2022. The balance of above A-Shares repurchased but not yet cancelled as at end of month is 32,954,084 shares (treasury shares), and will be used in other share incentive plans.

During May 2023 to March 2024, 83,349,394 A-Shares were repurchased but not yet cancelled, 25,117,000 A-Shares had been transferred to The 2023 A-Share Core Employee Stock Ownership Plan during July 2023.
