

Please write on the top of the cover in capital letters as "COMMERCIAL BID" and address it to SENIOR MANAGER (STORES), TAMILNADU NEWSPRINT AND PAPERS LIMITED – UNIT II, Mondipatti, Trichy Dist., Pin: 621 306, Tamilnadu.

The Price Bid (Annexure – III) should also be sent in a separate sealed cover super scribing Tender No and the Due date with "PRICE BID" written in capital letters on the top of the cover. Both the covers containing "COMMERICAL BID" and "PRICE BID" are to be put in one sealed cover super scribing the TENDER NO and DUE DATE and addressed to SENIOR MANAGER (STORES), TAMILNADU NEWSPRINT AND PAPERS LIMITED – UNIT II, Mondipatti, Trichy Dist., Pin: 621 306, Tamilnadu.

The due date for submission of COMMERCIAL BID (EMD SCHEDULE along with DD) and PRICE BID is 28.01.2022 at 3.00 PM. Offers received after 3.00 PM will not be considered.

The Commercial Bid will be scrutinized first and those who qualify in the Commercial Bids satisfying all the tender conditions will only be considered for Price bid stage.

# **QUALIFYING FACTORS OF THE TENDER:**

Please note that the following are the qualifying factors of the Tender. Tenderers who do not comply with the conditions with documentary proof (wherever required) will not be qualified in the Tender for Price Bid stage.

- 1. Tender should be submitted along with Commercial Bid without fail.
- 2. Submission of tender within due date and time
- 3. Submission of EMD of Rs.75,000/- through Demand Draft only.
- 4. Acceptance of price validity as per tender.

# **PRICE BID STAGE:**

# At Price Bid stage, TNPL will follow the following methodology to finalise the tender:-

- 1. Price Bid will be obtained from the tenderer in a separate sealed cover along with Commercial Bid in another sealed cover.
- 2. TNPL will fix the opening price and minimum bid increment for the Forward auction. The date and time of Forward auction will be communicated to the tenderers who qualify in commercial bid separately.
- 3. After completion of the Forward Auction, on the same day or next working day at 4:00PM, TNPL will open the price bids of the qualified tenderers in the presence of interested tenderers.
- 4. The highest offer received through Forward auction or through Price Bid only will be considered for placement of order.

### **EARNEST MONEY DEPOSIT (EMD):**

An EMD amount shall be furnished by way of Demand Draft drawn in favour of Tamilnadu Newsprint and Papers Limited payable at Trichy. Other modes of EMD payment like IMPS, NEFT, RTGS etc are not acceptable. The EMD amount should be enclosed along with COMMERCIAL BID only.

TNPL will not entertain any request for adjusting the EMD from the tenderer's due / running bills or from the EMD / Security Deposit of any other tender participated by the tenderer.

Offers received without EMD will be rejected / disqualified.

The tenders submitted by those who have been black listed by TNPL shall be returned unopened.

<u>NOTE:</u> TNPL is not bound to accept the highest quotation. TNPL may accept or reject the highest quotation or any quotation at its sole discretion and go for re-tendering in case the highest rate obtained in the tender is considered as low.



The following material is available for sale at TNPL UNIT II, Mondipatti on "As is where is" basis.
 The tentative quantity is given in annexure-I and it may vary +/-10% on either side. In this connection please find enclosed the following:

- 2. a) PRICE VALIDITY: The firm price offer and forward auction offer should be kept valid for acceptance for a period of 60 days from the date of opening of price bid / forward auction whichever is later. No tenderer is permitted to withdraw their offer within the validity period of the tender or before finalization of the order. In such case EMD will be forfeited & tenderer will be blacklisted.
  - b) VALIDITY: The Sale Order is valid for a period of Six Months from the date of Sale Order.
- 3. The sale order may be issued to one/more parties at the discretion of TNPL
- 4. The tenderer shall be allowed to lift the scrap material only after 100 % advance payment for the quantity available including applicable TAXES on the day of despatch. The remittance has to be made either by EFT (Details Attached) or DD in favor of TAMIL NADU NEWSPRINT AND PAPERS LIMITED payable at TRICHY.
- 5. The tenderer should produce the GSTIN & PAN Number and a copy of the documentary proof along with Tender.
- 6. The **Scrap materials** can be inspected at our site on any working day between 10.00 AM and 04.00 PM.
- 7. Basic Rate Only to be quoted and applicable duties and taxes extra to the Tenderers' account. CGST 9%, SGST 9% & TCS 1% extra to tenderers account for tenderer from Tamil Nadu and for other state tenderers IGST 18% & TCS 1% extra.
- 8. SCOPE OF WORK: Collection and removal of scrap materials on "As is where is" basis. The tenderer shall remove the scrap material as per TNPL requirement. Loading of scrap material into the vehicle has to be arranged by the tenderer.
- 10. Rights of participation will be for people who after inspecting the material, pre qualify themselves by paying the EMD and who have not been previously blacklisted by TNPL. Final decision regarding participation will be with TNPL.
- 11. Sale confirmation, Sale Order, Invoices etc. will be released only in the name of the tenderer who has initially registered and participated in the auction. There will not be any change between the registration and completion of transaction.
- 12. In the event of the failure of the tenderer by way of a default in payment for the material being disposed, partial lifting of materials or non-compliance of any of the terms mentioned herein, the contract will automatically stand terminated and the EMD will stand forfeited for the breach of contract by the tenderer. In this case, the company reserves the right to dispose off the balance scrap and the said tenderer will have no claim whatsoever.
- 13. The rates offered by the highest tenderer will remain firm throughout the contract.
- 14. While taking delivery of the scrap materials, if any damage is caused to the premises or other machinery lying nearby, the Company shall recover all such costs required to reinstate the damage into the original position and stop delivery of the material till all the costs are paid.
- 15. Material lifting shall be as per the guidelines of TNPL only. Tenderer shall have no right to choose / pick the scrap material out of due total lot.


- 16. **INSURANCE FOR WORKMEN EMPLOYED BY THE TENDERER:** The tenderer should submit Insurance Policy under workmen compensation Act for the staff / workmen engaged for coordination / material lifting by them for the entire contract period before commencement of work. TNPL is not responsible for any accidents occurred to employees of tenderer/ any other person engaged by the tenderer.
- 17. **DRIVING LICENCE:** The drivers employed by the tenderer shall posses' valid driving license and TNPL reserves the right to check these papers and certificate of Insurance as and when required. TNPL in no way be responsible for violation of transport regulations by the tenderer and their crew.
- 18. The tenderer shall be responsible to ensure that their employees follow safety regulations and as per TNPL stipulations and other statutory regulations. Tenderer shall ensure that all his workmen on site use safety belts, gloves, helmets, masks, Safety Shoes, Goggles etc., as necessary for their safety.
- 19. Once the scrap material is taken out of the factory gate, tenderer will be solely responsible for all sort of claims like shortage, missing parts, damage, incident, accident, loss of wood bark etc.
- 20. Should the tenderer wish to take delivery of the scrap material through a representative, he must authorize the latter by a letter of authority, which shall be presented to the officer concerned. The officer concerned may in his entire discretion decline to act on any such authority and it shall be for the Tenderer to satisfy the officer concerned that the authority is genuine. Delivery to such person shall be sole responsibility of the tenderer and no claim shall lie against the Company on any account whatsoever, if delivery is offered to a wrong person.
- 21. In case of any dispute regarding the contract, the decision of the Company shall be final and binding. If there is any dispute as to the last or highest bid, the dispute shall be determined by the company and their decision shall be final and binding to all.
- 22. Tenderer and his men are subject to the security rule of TNPL in force while in the TNPL premises. Tenderers workmen, agents or representatives shall not commit any nuisance, theft or include in any anti-social activities in the premises and the tenderer shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.
- 23. The quantity indicated is approximate and no guarantee can be given regarding actual quantity.
- 24. **Subletting of contract:** The tenderer shall not assign or <u>sublet the</u> order or any part thereof or allow any person to become interested therein in any manner, whatsoever, without specific /written permission from TNPL.
- 25. Cancellation of order and penalty: In the event of not taking delivery of scrap materials in time, TNPL reserves the right to dispose of the material as it deems fit at their own discretion to any other person and recover any loss due to this from the original tenderer. In the event of unsatisfactory performance, TNPL reserves the right to cancel the order. In the event of such cancellation, the security deposit & EMD amounts will be forfeited. In addition, TNPL also reserves the right to recover such amounts as it deems fit from the tenderer towards the breach of contract and due to unsatisfactory performance. TNPL's decision will be final and binding.
- 26. Any dispute arising out of the sale shall be subject to jurisdiction of the Courts situated at Trichy.
- 27. **Commencement of work**: The tenderer shall commence the work immediately within 3 days on receipt of intimation /award of sale order.
- 28. Tenders liable for rejection:

The following tenders are liable for rejection summarily:

- Tenders submitted by Tenderers who resort to canvassing.
- b. Tenders who do not fulfill all or any of the condition laid down in the tender document.
- c. Tenders, which contain uncalled remarks and
- d. Tenders received after due date and time.
- 29. **Rejection of Tender:** TNPL will not assign any reason for rejection of any tender. TNPL shall have the right to reject any or all tenders/ to split order on two or more tenderers / to go for retender without assigning any reason / to release order on part quantity
- 30. **TNPL not responsible for tenderer employees:** The tenderer may employ such employees as he may think fit and the employees so employed shall be the employees of the tenderer, for all purposes, whatsoever, and shall not be deemed to be in the employment of TNPL for any purpose, whatsoever. If under any circumstances whatsoever, TNPL is held liable or responsible in any

manner, whatsoever for the default or omission of the tenderer TNPL shall be reimbursed by the tenderer for the same, as also any other expenses or cost incurred by TNPL in any proceedings or litigation as a result of any such claim, demand or act on the part of the employees / representative of the tenderer.

31. In case the Partners or Directors or Proprietor of the Company are related to any of the employee of TNPL, a declaration to this effect giving the details of the Name of the Employee, Relationship, etc., should be provided separately.

- 1. TNPL would communicate the opening price, bid increment through mail / e-mail.
- On the auction date, Tenderers shall submit their bids in the website
   <u>www.tnpltenders.com</u>. As and when other Tenderers place the bids, they would have
   the opportunity to revise their bids upwards, if they wish to do so.
- 3. Tenderers must communicate their final bid amount by fax or E-mail to TNPL immediately after the bid event. This may be followed by a hard copy communication of price by post or courier.
- 4. TNPL's decision on sale order shall be final and binding
- Opening price: Opening price is defined as the highest initial price. Tenderers must bid higher than the opening price.
- 6. **Bid increment:** Bid increment is the minimum fixed amount by which the next bid value can be increased. TNPL reserves the right to change the bid increment during the course of bidding.






