

STATE OF ALABAMA PROCLAMATION

BY THE GOVERNOR

WHEREAS a general election was held in the State of Alabama on Tuesday, November 5, 2024, to elect certain state and federal officers;

WHEREAS the Alabama Code requires that all election returns sent to the Secretary of State be opened, counted, and certified in the presence of the Governor, the Secretary of State, and the Attorney General, or two of them, within 22 days after the election, *see* Ala. Code § 17-12-17;

WHEREAS, on Tuesday, November 26, 2024, the election returns from the 2024 General Election sent to the Secretary of State were in fact opened, counted, and certified in the presence of the Governor, the Secretary of State, and the Attorney General; and

WHEREAS the Alabama Code requires the Governor to declare the results of this election by publishing in "some newspaper at the seat of government," see Ala. Code § 17-12-18;

NOW, THEREFORE, I, Kay Ivey, as Governor of the State of Alabama, in accordance with the Constitution and statutes of the State of Alabama, do hereby proclaim the results of the 2024 General Election, as are on file and of record in the Office of the Secretary of State, to be as follows:
