OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 24-165 (State Attorney Executive Assignment)

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Eleventh Judicial Circuit of Florida, has advised Governor RON DESANTIS that Kevin Gerardo Gonzalez-Fajardo has been arrested for aggravated battery; and

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE has also advised the Governor that the victim in this case is a former employee of the state attorney's office; and

WHEREAS, the Honorable KATHERINE FERNANDEZ RUNDLE, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney regarding the investigation and prosecution of this case and all related matters regarding Kevin Gerardo Gonzalez-Fajardo; and

WHEREAS, the Honorable DENNIS W. WARD, State Attorney for the Sixteenth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable DENNIS W. WARD discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable DENNIS W. WARD, State Attorney for the Sixteenth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable KATHERINE FERNANDEZ RUNDLE, State Attorney for the Eleventh Judicial Circuit of Florida, regarding the investigation and prosecution of this case and all related matters regarding Kevin Gerardo Gonzalez-Fajardo.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Eleventh Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3. All residents of the Eleventh Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including August 7, 2025.

Section 5. The Assigned State Attorney shall notify the Governor on or before July 7, 2025, if additional time is required.


