# CAMPE Community Advisory Board (CAB)

Advancing Contextual Analysis and Methods of Participant Engagement April 2024

# Introduction

The Office of Planning, Research, and Evaluation (OPRE) launched the Advancing Contextual Analysis and Methods of Participant Engagement in OPRE (CAMPE) project to assist OPRE in better understanding, incorporating, and advancing equitable research practices. In September 2021, OPRE awarded a contract to the Urban Institute (Urban) to execute the project.

CAMPE is directly engaging people with lived experience by convening a Community Advisory Board (CAB). The term "CAB" is commonly used in research and evaluation practice and does not refer to a Federal Advisory Committee; OPRE will not seek consensus advice from the CAB, but rather will seek a variety of perspectives to inform the project.

The CAB is made up of thirteen members who have experience participating in and working with Administration for Children and Families (ACF) programs. They represent diverse geographies, experiences, and identities (Table 1). The CAB is not intended to be a representative sample of the populations that participate in ACF programs but is instead designed to bring lived experience as an additional, highly relevant form of expertise that is often missing or undervalued in our workplaces, projects, and products.

The CAB is providing input on an OPRE editorial style guide; a learning agenda on the topic of welfare and family self-sufficiency; language and procedures used to obtain informed consent in OPRE research studies; and guidance for survey development.




I joined the CAB because I am passionate about serving my community and implementing best practices to help improve lives.

In this role, I review and monitor clients' casefiles to support staff. I have more than 10 years' experience working with the Bureau of Population, Refugees, and Migration (PRM) and the Office of



Refugee Resettlement on programs like the Reception and Placement Program and Refugee Support Services. I joined the CAB because I am passionate about community engagement in research and in the refugee resettlement process.

I have lived expertise in the following areas: family welfare, home visiting, employment and job training, immigration services, refugee resettlement, and casefile monitoring.

#### Dillon Silva

My name is Dillon Silva (he/him), and I am based in Atlanta, Georgia. I have my GED and have had training and classes in computer technology.
