## **Indiana Advisory Committee to the U.S. Commission on Civil Rights Announces Public Briefing on Hate Crimes in Indiana**

The Indiana Advisory Committee (Committee) to the U.S. Commission on Civil Rights (Commission) is examining how hate crimes are processed and treated in Indiana. This study includes an assessment of whether gaps or loopholes in state and federal data, policies, and laws impair hate crime law enforcement and reporting.

The Committee is hosting additional briefings to take testimony from a broad range of subject-matter experts. The invited experts will offer national and/or Indiana-specific data and information on this topic. Indiana Committee Chairperson Diane Clements-Boyd said, “The Indiana Advisory Committee continues hearings on the unfortunate reality of hate crimes and bias incidents. The Committee’s September hearings examined the: (i) impact of increased hate crimes and incidents against AAPI (Asian American and Pacific Islander), Jewish and Muslim persons and their communities, and (ii) efforts to heal them and by whom. Our November hearings will examine the impact and healing efforts for Black and LGBTQ+ persons and communities in Indiana. Committee members look forward to the invited panelists educating and informing us about: (i) the types and circumstances for treating domestic violence claims as hate crimes; (ii) strategies that will help to improve more accurate and transparent hate crime reporting, such as

allowing victims to report hate crimes & bias incidents to **trusted community-based organizations**, in addition to law enforcement entities; (iv) the key components of a model hate crime law.”

After announcing the panel briefing has ended, the Chairperson will invite members of the public, if any, to make brief statements on the briefing topic, with each statement not exceeding five minutes. Members of the public may submit written comments via email. Written comments submitted within 30 calendar days after the panel briefing, i.e., by December 22, 2024, will be included in the briefing record.
