H.R. 7914 would require the Administration to impose sanctions on the Popular Resistance Committees, a coalition of armed groups in the Palestinian terrirtories, and on any affiliated foreign persons or entities. The bill also would require the Administration to regularly report on whether the Popular Resistance Committees and Lions' Den, a violent Palestinian group operating in the West Bank, should be designated as Specially Designated Terrorist Organizations. Any foreign persons or entities associated with the Specially Designated Terrorist Organizations are subject to sanctions.

The Administration has existing authority to sanction foreign persons and entities determined to pose a threat to national security and to designate organizations as a Specially Designated Terrorist Organization. If the enactment of H.R. 7914 leads the Administration to broaden those sanctions, additional persons would be subject to sanctions. More people would be denied visas by the Department of State, resulting in an insignificant decrease in revenues from fees. Although most visa fees are retained by the Department of State and spent, some collections are deposited into the Treasury as revenues. Denying foreign nationals entry into the United States also would reduce direct spending on federal benefits (emergency Medicaid or federal subsidies for health insurance, for example) for which those people might otherwise be eligible.

In addition, the bill would block transactions involving certain assets and property that are in the United States or that come under the control of people in the United States. People who violate those sanctions would be subject to civil or criminal monetary penalties. Those penalties are recorded as revenues, and a portion can be spent without further appropriation.

Using data about similar sanctions, CBO estimates any additional sanctions would affect a small number of people; thus, enacting H.R. 7914 would have insignificant effects on revenues and direct spending, and would, on net, reduce deficits by insignificant amounts over the 2024-2034 period.

Based on the cost of reports similar to those required by this bill, CBO estimates that preparing those reports would cost less than \$500,000 over the 2024-2029 period. Such spending would be subject to the availability of appropriated funds.

H.R. 7914 would impose a private-sector mandate as defined in the Unfunded Mandates Reform Act (UMRA). Sanctions would prohibit individuals or entities in the United States from engaging in transactions involving assets and property that have been frozen. Those transactions are otherwise permitted under current law. The cost of the mandate would be any income lost because of the prohibition. CBO expects that because a small number of people or entities would be affected, the loss of income from any incremental increase in restrictions imposed by the bill would be small as well. CBO estimates that the cost of the mandate would fall well below the annual threshold established in UMRA for private-sector mandates (\$200 million in 2024, adjusted annually for inflation).

H.R. 7914 contains no intergovernmental mandates as defined in UMRA.
