Welcome

Wallops Island National Wildlife Refuge was established in 1975 as an inviolate sanctuary for migratory birds. The 373-acre refuge vision is "Chincoteague and Wallops Island National Wildlife Refuges encompass extraordinary and ever-changing lands at the edge of the sea, a place where unique habitats and wildlife flourish. In partnership with others, the refuges are a vital part of a larger system of protected lands and waters on the Delmarva Peninsula, critical to migratory birds. People from around the world can visit the refuges to learn, recreate, refresh themselves, be inspired by wildlife and wild lands, and renew their connection with nature".

Safety

Areas of the refuge may be closed for management purposes, or other hazardous conditions that pose a threat to human health and safety. Such closures will be posted at the Hunt Information Kiosk.

Firearms

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32).

Dogs

We allow the use of dogs for migratory game bird hunting, but we prohibit the use of dogs for upland and big game hunting.

Hunting Regulations

Hunting regulations are designed to provide safe recreational opportunities through wise use of renewable wildlife resources. Hunting is permitted in accordance with Federal regulations governing public use on National Wildlife Refuges as set forth in Title 50 of the Code of Federal Regulations.

Hunting will be in accordance with applicable State of Virginia regulations subject to the conditions stated herein. Brochures may be obtained by mail, at the refuge headquarters (Chincoteague NWR), or from the refuge website.

All members of a hunt party must possess a refuge hunt permit and be actively engaged in hunting. We allow an exception or those persons aiding a disabled person who possesses a valid State-issued Commonwealth of Virgnia Disabled Resident Lifetime License or Commonwealth of Virginia Resident Disabled Veteran's Lifetime License.

Access

Hunters may access the refuge two hours before legal sunrise until two hours after legal sunset.

Parking is allowed only in designated areas as shown on the attached map.

Tree Stands, Blinds and Decoys

We allow the use of portable tree stands, portable blinds and decoys, but you must remove them at the end of each day's hunt.

^{*}Nontoxic ammunition will be required to hunt all species on the refuge starting September 2026.

Prohibited Activities

- By law, recreational activities on national wildlife refuges are prohibited unless expressly permitted
- Possession of alcoholic beverages
- Camping and fires
- Searching for or removal of any natural items such as antlers, skulls, plants, historic, and archaeological features
- Use of electronic or photographic trail monitoring devices
- Marking or flagging any tree or other refuge feature with reflectors, paint, or other substance
- Permanent tree stands, nails, screw-in steps, or other items that penetrate the outer bark of a tree
- Night hunting
- Hunting within 100 feet (30.5 m) of any building, road or trail, whether improved or unimproved
- Deer Drives: we define a "deer drive" as an organized or planned effort to pursue, drive, chase, or otherwise frighten or cause deer to move in the direction of any person(s) who is part of the organized or planned hunt and known to be waiting for the deer
- Turkey hunting
- ATVs/UTVs, bicycles, e-bikes and saddled animals
