Who owns and who implements the policy?

Department for Infrastructure – Rivers Directorate own and will implement the TGN.

Background

Rivers Directorate is responsible for delivery of construction schemes for:-

- 1. Flood Alleviation.
- 2. Improvements to the drainage infrastructure to facilitate increased rate of storm run-off from proposed new development.
- 3. Refurbishment / repair of existing assets on designated watercourses.
- 4. Drainage improvements throughout the network.

The powers delegated to Rivers Directorate by the Department for Infrastructure as the statutory Drainage and Flood Defence authority for Northern Ireland derive from the Drainage (Northern Ireland) Order 1973.

The Drainage (NI) Order 1973 is the legislative framework under which Rivers Directorate carries out drainage projects. The Order allows for two approaches to carrying out works:-

- The Article 12 procedure is applied to drainage schemes. Drainage schemes are generally flood alleviation and drainage infrastructure schemes: and
- The Article 21 procedure is applied to drainage works. Drainage works are generally the routine repair and maintenance of existing infrastructure, flood defences and watercourses.

It is recognised that there are different options available to Rivers Directorate for the delivery of construction schemes as outlined within the policy. The means of design and construction of capital schemes will depend on their scale, complexity and availability of resources.

The policy provides guidance to Rivers Directorate to enable a standardised approach to the delivery of its construction schemes. The policy provides guidance the two approaches to carrying out works under The Drainage (NI) Order 1973. The process is set out within the guidance in a systematic way, with a table identifying each scheme financial threshold and the corresponding

Drainage Order Article they fall under.

The policy enables the delivery of construction schemes which will alleviate flooding, the final outcome will have a positive impact on the recipient community either urban or rural if the works are viable by decreasing the risk of flooding.

This is internal guidance for Rivers Directorate staff involved in the delivery of minor capital works and action will only take place when the criteria as set out in this guidance is met fully.
