UNOPPOSED MOTION TO EXTEND PROCEDURAL SCHEDULE

Pursuant to 49 C.F.R. §1104.7(b), Petitioner, Philadelphia Belt Line Railroad Company (PBL), submits this motion for an extension of the due date for PBL to reply to Richmond Waterfront Industrial Park, LLC's (RWIP) Opening Statement, which was filed on October 15, 2024 and for a corresponding extension to the due date for RWIP to file its rebuttal. Pursuant to the procedural schedule established by the Surface Transportation Board in its stamped decision issued on October 1, 2024, PBL's reply is currently due November 22, 2024 and RWIP's rebuttal is currently due December 23, 2024. Pursuant to this motion, PBL is requesting that the date for PBL's reply be set to December 6, 2024 and that RWIP's rebuttal due date be set to January 6, 2025. The extensions are necessary to accommodate various involved parties' holiday schedules, the retirement of one of RWIP's attorneys at the end of 2024, and to provide an opportunity for possible settlement discussions. Counsel for PBL is authorized to state that RWIP does not oppose this motion. Accordingly, RWIP respectfully requests that the remaining procedural schedule for this proceeding be amended to allow PBL to file its reply on December 6, 2024 and for RWIP to file its rebuttal on January 6, 2024.
