1. The organization chart identifies Hudson Transit Lines, Inc as acquiring Chenango Valley Bus Lines, Inc., but this acquisition is not discussed in the application.

The organization chart included this as an error. Shortline Transit LLC is acquiring both of these Coach USA Subsidiaries, as reflected in the corrected enclosed chart.

2. Please specify the states in which Elko Inc. operates.

Elko Inc. operates primarily in Nevada, with some services provided in Utah and California.

3. Please clarify the ownership of 1485832 B.C. Unlimited Liability Company – the organization chart indicates that it is owned by Bus Company Holdings US LLC, but the application indicates that it is owned by Bus Company Holdings Topco LP.

A corrected chart is enclosed, which (consistent with the application) identifies 145832 B.C. Unlimited Liability Company as being owned by Bus Company Holdings Topco LP. Please note that, since the application was filed, the name of 145832 B.C. Unlimited Liability Company has been changed to Newcan Coach Company ULC. This new name is reflected in the enclosed chart.

4. Please clarify whether Renco exercises any direct control over any motor carriers and whether it should be an applicant based on the information contained in your July 12, 2024 submission.

Renco does not control any motor carriers. Upon consummation of, and as a result of the Transaction, Renco will not control day-to-day bus services or operations of the Acquisition Companies. It only has an ownership interest in the Acquisition Companies. Given that Renco will not control day-to-day bus services or operations of the Acquisition Companies, it does not believe that it should be an applicant. If the STB disagrees, please advise.


