ERRATA TO OCTOBER 31, 2024 VERIFIED NOTICE OF EXEMPT ABANDONMENT

Since submitting Norfolk Southern Railway Company's ("NSR") verified notice of exemption ("Notice") on October 31, 2024, 1 counsel for NSR has discovered a mistake that resulted in a discrepancy regarding the number of newspaper publications listed in the Certification of Newspaper Publication contained in Exhibit C. The Notice incorrectly indicates that the "Notice of Intent to Abandon Rail Service" was "published in four2 newspapers as follows:

- On October 27, 2024 in the Spartanburg Herald Journal;
- On October 30, 2024 in The Hendersonville Lightning;
- On October 27, 2024 in the Tyron Daily Bulletin; and,"

¹ NSR filed its Notice to abandon rail service over an approximately 31.3-mile rail line, extending from approximately Milepost W 26.0 +/- to approximately Milepost W 57.3 +/- (the "Line") in the Counties of Henderson and Polk in North Carolina and the Counties of Greenville and Spartanburg in South Carolina.

² Originally, NSR intended to publish the newspaper notice in four newspapers, but due to timing considerations, NSR had to switch out one newspaper for another and in doing was able to publish in three (3) newspapers, which collectively covered the entire area proposed for abandonment.

NSR is submitting this errata to correct the incorrect reference to the number of newspaper publications. NSR respectfully requests that the Board substitute the following page in the Notice: page 14.³ Please feel free to contact me should you have any questions.
