**MOTION TO EXTEND DEADLINE FOR FILING PUBLIC VERSIONS OF BRIEFS  
AND WORKPAPERS FOR 24 HOURS**

Pursuant to the Surface Transportation Board’s (“Board”) August 19, 2024 Decision, Amtrak is to file an opening statement by October 7, 2024, railroad party replies are due by December 23, 2024, railroad party rebuttals to non-party replies are due by February 21, 2025, and Amtrak’s rebuttal to all replies is due by February 21, 2025. Amtrak hereby requests that the Board permit all parties to file the Public (redacted) versions of their briefs, and submit any workpapers, 24 hours after each applicable deadline. No extension of the filing date for the Highly Confidential or Confidential versions of the briefing is requested.

Amtrak anticipates that its briefing will extensively cite material in the investigative record that host railroads have designated Highly Confidential or Confidential under the Protective Order. To ensure that such information is fully and accurately redacted from its Public filings, Amtrak respectfully requests this 24-hour extension for the filing of the Public version of its briefing, and to submit any supporting workpapers. The proposed extension will not affect the Board, which will receive the full Highly Confidential filings as currently scheduled, nor will it affect the parties, who will receive the full Confidential filings as currently scheduled.

Yesterday afternoon, at approximately 2:30, Amtrak contacted counsel for the other parties in this proceeding to ascertain their position on the Motion. Through counsel, UP has indicated

that it consents to the motion; CPKC, BNSF, and SCRRRA have indicated that they do not oppose the motion; other parties have not yet provided a position.
