# PORTLAND & WESTERN RAILROAD, INC. - ABANDONMENT EXEMPTION - IN WASHINGTON COUNTY, OR

### ENVIRONMENTAL/HISTORIC REPORT

Portland & Western Railroad, Inc. ("PNWR") owns the rail, track materials and other personal property comprising the rail line between Milepost 31.3 and Milepost 32.2 in Tigard, OR, and an exclusive easement over the underlying property (together, the "Subject Line"). The underlying property is owned by the Oregon Department of Transportation ("ODOT"). PNWR will be seeking exemption authority for the abandonment of the Subject Line. No stations exist on the Subject Line. The Subject Line traverses through United States Postal Service ZIP Code 97223, entirely in Washington County, OR. Maps of the Subject Line are attached as Exhibit A.

PNWR plans to seek Surface Transportation Board ("STB") authorization for its abandonment through a notice of exempt abandonment pursuant to the provisions of 49 CFR §1152.50 on or after November 18, 2024. This report is being filed in connection therewith, and in accordance with the requirements of 49 CFR 1105.7 and 1105.8. To prepare this report, Applicant consulted with various state and federal agencies as required by the Board's regulations. *See* the letters attached as Exhibit B. Based on the written responses received by Applicant to-date attached as Exhibit C, Applicant states as follows:

### ENVIRONMENTAL REPORT

(49 CFR 1105.7)

### 1. PROPOSED ACTION AND ALTERNATIVES

Applicant originally acquired the Subject Line from the Burlington Northern and Santa Fe Railway Company in 1997.<sup>1</sup> The Subject Line runs parallel to an active PNWR rail line that PNWR is not abandoning and holds independent common carrier authority for the active segment.<sup>2</sup> No local service has been provided on the Subject Line for over 17 years and at some point, since its last service the track was removed, and the right-of-way was converted to a walking and bicycling path. PNWR will not be salvaging any rail ties or other track materials on the Subject Line because no such materials currently exist.

### 2. EFFECTS ON THE TRANSPORTATION SYSTEM

Applicant believes that the abandonment would have no effect on the transportation system because an active PNWR line runs parallel to the Subject Line, there has been no local or overhead service on the Subject Line for over 17 years, and no traffic will be diverted. Applicant sent a consultation letter regarding the proposed abandonment to ODOT. *See Exhibit B.* ODOT has not responded to the PNWR letter.

### 3. LAND USE

(i) Applicant is unaware of any regional or local land use patterns with which the proposed abandonment would be inconsistent. Applicant consulted with the following agencies regarding the proposed abandonment that may be concerned with land use issues: Oregon Department of

Environmental Quality ("ODEQ"), the Natural Resources Conservation Service ("NRCS – Oregon"); Natural Resources Conservation Service ("NRCS – National"); U.S. Environmental Protection Agency Region 10 ("EPA"); NOAA National Geodetic Survey ("NGS"); U.S. Bureau of Land Management Oregon-Washington State Office ("BLM"); U.S. Army Corps of Engineers Portland District; Washington County Board of Commissioners; National Park Service, Pacific West Region ("NPS – Pacific West Region"); National Park Service ("NPS – National"); U.S. Fish and Wildlife Service Region 1 ("FWS"). Copies of these letters are attached as part of Exhibit B. To date, none of these agencies have provided a response.

- (ii) Applicant does not believe that the proposed abandonment will have any adverse effect on any prime agricultural land. Consultation notices were sent to the potentially concerned agencies listed in paragraph 3(i) above, and as indicated, none of these agencies have provided a response.
- (iii) Applicant does not believe that the abandonment is inconsistent with any coastal zone plans because the project is not in Oregon's coastal zone.<sup>3</sup> A consultation notice was sent to the Oregon Department of Land Conservation and Development, Oregon Coastal and Ocean Program Management. Applicant received a response from this Department informing it that the project is not in Oregon's coastal zone. A copy of the response is included as part of Exhibit C.
- (iv) Applicant believes that the right of way may be suitable public purposes. Applicant understands that the Subject Line is currently being utilized as a walking path.

### 4. ENERGY

Since there has not been any local service on the Subject Line for more than 17 years,

- (i) the proposed abandonment will have no effect on the transportation of energy sources;
- (ii) the proposed abandonment will have no effect on recyclable commodities;
- (iii) the proposed abandonment will have no effect on overall energy efficiency; and
- (iv) the proposed abandonment will not divert any traffic from rail to motor carriage.

The effects of the proposed abandonment will not exceed the thresholds set forth in 49 CFR 1105.7(e)(4)(iv).

### 5. AIR

Since there has not been any local service on the Subject Line for over 17 years, the proposed abandonment will not result in any increases in rail or truck traffic or rail yard activity. The effects of the proposed abandonment will not exceed the thresholds set forth in 49 CFR 1105.7(e)(5).

### 6. **NOISE**

Applicant does not believe that the proposed abandonment will result in any increase in noise levels.

### 7. **SAFETY**

Applicant does not believe that the proposed abandonment will have any adverse effect on public health or safety.

### 8. **BIOLOGICAL RESOURCES**

(i) Applicant has consulted with the FWS, as well as to the following agencies that are potentially concerned with biological resources: ODEQ, NCRS – Oregon, NCRS – National, BLM, U.S. Army Corps of Engineers, NPS – Pacific West Region, NPS – National, FWS.

Copies of these consultation letters are attached as part of Exhibit B. Applicant has not received any responses from these agencies.

(ii) Applicant does not believe that there are any wildlife sanctuaries or refuges, National or State parks or forests in the vicinity of the proposed abandonment. Consultation letters were sent to the agencies identified in the paragraph 8(i), and Applicant has not received any responses.

### 9. WATER

- (i) The proposed abandonment will be handled in a manner that is consistent with the applicable local, State and Federal water quality standards. Applicant consulted with the agencies identified in paragraph 8(i), and as noted in paragraph 8(i) has not received any responses.
- (ii) Applicant sent a consultation letter regarding the proposed abandonment to the U.S. Army Corps of Engineers. A copy of this letter is attached as part of Exhibit B. PNWR has not received a response.
- (iii) Applicant does not believe that any Clean Water Act permits will be required in connection with the proposed abandonment or any salvage. Consultation letters were sent to ODEQ and EPA. Neither agency has yet responded.

### 10. **PROPOSED MITIGATION**

Since no adverse environmental impacts are expected, no mitigation is proposed.

11. **ADDITIONAL INFORMATION FOR RAIL CONSTRUCTION**Not applicable.

### 12. **CONSULTATION**

As shown by the copies of letters attached as Exhibit B, Applicant has consulted with the following agencies: ODEQ, NRCS – Oregon, NRCS – National, EPA NGS, Oregon Depart. Of Land Conservation and Development BLM, U.S. Army Corps of Engineers, the Washington County Board of Commissioners, NPS – Pacific West Region, NPS – National, FWS.

None of the above agencies provided a response.

### 13. **CERTIFICATIONS**

Applicant certifies that:

- (a) It consulted with the agencies listed in 49 CFR 1105.7, as described in paragraph 12 above.
- (b) On this date, it sent copies of this report to each of the agencies consulted as shown on the attached certificate of service.
- (c) Notice of the proposed abandonment was published in the *Oregonian* on October 23, 2024. A copy of the form of notice and the proof of publication are attached as Exhibit D.
- (d) Applicant will not file its verified notice of abandonment until at least twenty (20) days after the consulted agencies have been served with a copy of this report.

### HISTORIC REPORT (49 CFR 1105.8)

### 1. U.S.G.S TOPOGRAPHIC MAP

A U.S.G.S. topographic map showing the location of the proposed abandonment are attached as Exhibit E.

### 2. **DESCRIPTION OF RIGHT OF WAY**

The Subject Line extends between Milepost 31.3 and Milepost 32.2 in Tigard, OR (the "Subject Line") extending approximately 4,111 feet. It is in the City of Tigard, OR a city of approximately 55,000 residents within the Portland metro area. It is situated amongst an urbanized area of town and lies along an active PNWR railroad line. The right of way is generally 60 feet wide. PNWR owns an exclusive easement over the underlying property.

ODOT owns the underlying property.

The City of Tigard has converted the Subject Line into the Tigard Heritage Trail, the city describes the trail as a "popular bike and pedestrian pathway [celebrating] local heritage and identity as a 'pedestrian boulevard' with historic and cultural landmarks."<sup>4</sup>

### 3. PHOTOGRAPHS OF HISTORIC STRUCTURE(S)

The Subject Line has no visible structures 50 years old or older on the right-of-way and therefore, no photographs are included herein.

### 4. DATES OF CONSTRUCTION OF HISTORIC STRUCTURE(S)

As noted in paragraph 3 above, no historic structures exist on the right-of-way.

### 5. HISTORY OF CARRIER OPERATIONS IN THE AREA

PNWR believes that the Subject Line was originally built by the Oregon Electric Railway. Applicant originally acquired the Subject Line from BNSF Railway, Inc. in 1997. 
The Subject Line runs parallel to an active PNWR rail line that PNWR is not abandoning and holds independent common carrier authority for the active segment. 
No local service has been provided on the Subject Line for over 17 years and at some point, since its last service the track was removed, and the right-of-way was converted to a walking path. ODOT owns the underlying property. There has been no service provided over the Subject Line proposed for abandonment for over seventeen years.

### 6. SUMMARY OF STRUCTURE DOCUMENTATION

There are no historic structures on the Subject Line, and accordingly, PNWR is not submitting any summary of documentation relating to the structures.

### 7. OPINION REGARDING CRITERIA FOR LISTING

Based on readily available information in PNWR's possession, PNWR does not believe the Subject Line represents an historical resource or that any protective conditions are warranted.

Applicant has given notice of the proposed abandonment and is consulting with the State Historic Preservation Office at the Oregon State Historic Preservation Office ('SHPO"). The SHPO responded to PNWR's notice via letter dated October 25, 2024 stating that the Subject Line is not eligible for listing in the National Register of Historic Places and that no historic properties will be affected. Copies of these letters are included as part of Exhibit F.

### 8. ENVIRONMENTAL CONDITIONS

Applicant is unaware of any prior subsurface ground disturbance or fill, or environmental conditions which might affect the archeological recovery of resources or the surrounding terrain.

Because no track remains on the Subject Line, no salvage work will be conducted.





This letter is to advise you that the Portland & Western Railroad, Inc. ("PNWR") intends to file for the abandonment of a segment of its line between Milepost 31.3 and Milepost 32.2 in Tigard, OR (the "Subject Line") extending approximately 4,111 feet. PNWR is proposing to abandon the perpetual freight easement it owns over the Subject Line; the underlying property is owned by the Oregon Department of Transportation ("ODOT").

The Subject Line runs parallel to an active PNWR rail line that PNWR is not abandoning. PNWR holds independent common carrier authority for each segment. A map of the Subject Line is enclosed. The Subject Line traverses through United States Postal Service ZIP Code 97223 entirely in Washington County, OR.

PNWR plans to seek Surface Transportation Board ("STB") authorization for its abandonment of the Subject Line through a notice of exempt abandonment pursuant to the provisions of 49 CFR § 1152.50 on or after November 18, 2024, in Surface Transportation Board Docket No. AB 541 (Sub. No. 5X).

Based upon information in PNWR's possession, the Subject Line does not contain federally granted rights of way; the owner of the underlying property, ODOT, may have additional

information. Any documentation in PNWR's possession related to federal granted rights of way will be made available promptly to those requesting it.

No local service has been provided on the Subject Line for over 17 years and at some point, since its last service the track was removed, and the right-of-way was converted to a walking path. PNWR does not believe that there are any alternatives to the proposed action. PNWR believes that the abandonment will not have a significant effect upon the environment.

In advance of preparing an environmental and historical report as required by applicable STB regulations, we are consulting with appropriate agencies such as yours as to any concerns which they may have as to any effects of the proposed abandonment on historical resources.

We would appreciate an expression from you by October 28, 2024 that, within the area of your authority, you do not perceive that the abandonment will have a significant effect upon any historical resources (or expressing any concerns that you have). 
