Notice of Intent to Terminate Service

Dear Ms. Brown:

YCR Corporation ("YCR") is filing this Notice of Intent to Terminate Service ("Notice") under 49 C.F.R. § 1150.24 for the above-referenced modified certificate of public convenience and necessity ("modified certificate"). YCR's modified certificate authority applies to a rail line between milepost 0.0 at Toppenish (Wesley Junction) and milepost 20.56 at White Swan (including a 1.63 mile industrial spur at White Swan) all within Yakima County, Washington (the "Line"). YCR's leasehold in the Line has been terminated. For that reason, YCR hereby invokes the Board's procedures to end its modified certificate authorization with respect to the Line, and thereby to cease to possess a common carrier status (since the Line constituted the entirety of YCR's rail operations).
