#### VERIFIED NOTICE OF EXEMPTION

Pursuant to 49 C.F.R. 1180.4(g) (1) Nathan Evans, a non-carrier hereby files this notice of exemption under 49 C.F.R. \$1180.2(d) (2) for an exemption from the prior approval requirements of 49 U.S.C. \$11323 for his continuance in control of NATHAN EVANS the Columbia & Reading Railway Co. LLC (hereinafter CORY) a carrier for which he has an agreement to purchase 51% of the LLC membership interest. Mr. Evans submits the following information required by Board Regulations.

### 1. 49 C.F.R. § 1180.6(a)(1)(i)

Telephone 609-792-6851. Email <u>ifiorilla@Dyerpeterson.com</u>. The transaction is a class exemption from 49 U.S.C. 11323(a)(4) for Mr. Evans to continue in control of CORY which is a

Class III carrier and which he is acquiring a controlling interest of its LLC membership Interest as a result of the control of the Elizabethtown Industrial Railroad LLC (hereinafter EZR) another Class III rail carrier, which Mr. Evans controls through the 100% LLC membership interest.

Acquisition of control of a carrier required Board approval under 49 U.S.C. § 11323 (a)(4). An application for such approval is required by 49 U.S.C. §11324(a). However pursuant to 49 C.F.R.§ 1180.2(d)(2) acquisition of such control is exempted from the prior approval requirements if:

- The railroads would not connect with each other or any railroads in the EZR corporate family.
- (2) The acquisition is not part of a series of anticipated transactions that would connect the railroads with each other or any railroad in the EZR corporate family.

Mr. Evans certifies that:

- The rail properties operated by EZR and those to be operated by CORY do not connect with each other or any railroads in the EZR corporate family; and
- 2) The continuance in control is not part of a series of anticipated transactions that would connect the rail lines EZR and CORY with each other or any railroads in the corporate family; and
- 3) The transaction does not involve a Class I or Class II rail carrier.

As such, the continuance in control qualifies for the class exemption under 49 C.F.R. 1180.2(d) (2).

The purpose sought to be accomplished by the proposed acquisition of control is to improve service and for the applicant to improve financial viability of the operation.

# 4. 49 C.F.R. § 1180.6 (a) (5)

The railroads which are controlled by the applicant operate in the following States: CORY operates wholly in the Commonwealth of Pennsylvania in the Borough of Columbia, County of Lancaster for 2.5 miles. The EZR operates within the Borough of Elizabethtown in Lancaster County Pennsylvania.

# 5. <u>49 C.F.R. 1180.6 (6)</u>

Attached to this notice are Exhibits A and B -which are maps showing the rail lines to be operated by CORY and EZR. Though the rail lines are both in the Commonwealth of Pennsylvania they will not operate in relation to each other.

# 6. 49 C.F.R..1180. 6 (7) (ii)

There is no document regarding purchase or the operation of CORY. Mr. Evans is only purchasing a controlling LLC interest to CORY but is not acquiring track or equipment nor are the operations of the CORY changing in any way.

#### **Labor Protective Conditions**

Pursuant to 49 U.S.C. S 10902, labor protective conditions do not apply and will not be imposed.
