## TDLR Releases New List Of Revoked Licenses

**AUSTIN** – The Texas Department of Licensing and Regulation (TDLR) has released the newest list of people who are no longer authorized to perform or offer to perform licensed services in Texas. This latest list includes actions TDLR has taken since October 2022 to safeguard consumers and protect public health and safety.

Among licenses revoked during this time were two Speech-Language Pathologists who billed for services that were not provided to patients and one Speech-Language Pathologist who falsified patient records.

TDLR also revoked a Fuel Metering and Quality Device registration and assessed a penalty of \$750 for failing to comply with fuel quality requirements. The suspension was probated for one year and the station can continue operating.

The agency revoked five massage therapist licenses, a massage instructor license and a massage establishment license. Sexual contact with clients was alleged in all seven of those cases. A man who was providing massage therapy services without a license was issued a cease-and-desist order for practicing unlicensed massage therapy.

TDLR revoked a master electrician license and an apprentice electrician license because the licensees had offered services without having an electrical contractor license.
