In this regard, the Company offered for sale and issued convertible debentures No. 6/2565 on May 9, 2022 in the amount of 20 million baht (20,000 units). The convertible debenture holders exercised the convertible debentures on June 21, 2022, amounting to 4 million baht (4,000 units). by ADVANCE OPPORTUNITIES FUND does not exercise the right to convert and ADVANCE OPPORTUNITIES FUND 1 exercised 4 million baht (4,000 units) . The remaining amount of convertible debentures No. 6/2022 is 5 million baht (5,000 units).
