<p>Tarl Investment Holdings (RF) Proprietary Limited, which is owned by an independent charitable trust whose trustees are independent of the Anglo American group, has entered into agreements with Tenon Investment Holdings Proprietary Limited (Tenon), a wholly owned subsidiary of Anglo American South Africa Proprietary Limited. Under the terms of these agreements, Tarl Investment Holdings (RF) Proprietary Limited purchased Anglo American plc shares on the market and granted to Tenon the right to nominate a third party (which may include Anglo American plc but not any of its subsidiaries) to take transfer of the Anglo American plc shares each has purchased in the market. Tarl Investment Holdings (RF) Proprietary Limited retains legal title to the shares until Tenon exercises its right to nominate a transferee.</p>
