QUARTERLY ACTIVITY REPORT (TO ACCOMPANY APPENDIX 4C)

Key areas of activity during the second quarter of the 2021 financial year were:

- GoGetta operations

The underlying GoGetta business operated profitably during the second quarter of the year, prior to accounting for the remediation costs in respect to the ASIC matter. The net cash used in operating activities for the quarter was negative \$433,000 after paying \$1.539 million for remediation, legal costs and independent remediation consultant costs.

- SIV Capital on-going

The major focus for the next three months will be the finalisation of the remediation program and preparation for the Court appearance expected to take place in April.
