REPORT ON QUARTERLY ACTIVITIES TO ACCOMPANY APPENDIX 4C

With the GoGetta remediation program having been completed, arrangements with full-time employees were finalised during the quarter. Included in the \$317k staff costs for the quarter were final payments to all remaining full-time employees of \$208k. From 6 December 2021 the operations of GoGetta are being carried out by a contractor who in addition, is providing accounting support.

The composition of the administration and corporate costs are detailed in the Appendix 4C; approximately \$350k of these are of a non-recurring nature.

The negative cash flow from operating activities in the second quarter arose due to reduced customer income (in line with the continued run down of the GoGetta book) and the non-recurring payments referred to above.
