

## COURT APPROVES SCHEMES FOR MERGER OF AUSTAR GOLD AND WHITE ROCK

AuStar Gold Limited (ASX:AUL) (**AuStar Gold**) and White Rock Minerals Ltd (ASX:WRM; OTCQX:WRMCF) (**White Rock**) are pleased to announce that the Federal Court of Australia (**Court**) has today made orders approving the share scheme of arrangement (**Share Scheme**) and option scheme of arrangement (**Option Scheme**) (together, the **Schemes**) for the proposed merger of AuStar Gold and White Rock.

### Lodgement of Court Orders and Suspension of Trading

It is expected that AuStar Gold will lodge a copy of the Court's orders with the Australian Securities and Investments Commission tomorrow, Thursday, 12 August 2021, at which time the Schemes will become legally effective. If this occurs, AuStar Gold will apply for suspension of trading of its shares and listed options on the ASX with effect from the close of trading tomorrow.
